## The Two Davids

The role that most churches find hardest to fill is, of course, the

Treasurer. Being Treasurer is a significant responsibility and one that requires real dedication and particular skills. We are exceptionally fortunate to have had such a strong team managing a very tricky period in the financial life of St Peter's. David Fisher was Treasurer of St Peter's for

more than 30 years before his retirement in October 2020. His faithful service to this church has been of inestimable value and his shoes very difficult to fill. In the period since David Fisher stood down there has been a massive amount of work required to bring stability and direction to this vital aspect of our shared

life. Various people were critical in managing this handover including, most particularly, our new Treasurer, David Hipkin. David has made brilliant progress in mastering the accounts and making them accessible in digitised form. We are incredibly fortunate to have such a competent



person now in charge. This puts us in a strong position to maintain responsible financial management into the future.

## The Cost of Ministry

The forecast budget for 2022 predicts costs of £359,000 (see back page). More than half of this total, £189,858, is accounted for by our 'Parish Share', almost all of which (93%) goes to pay for local clergy. The stipend, housing, pension and training of a full-time stipendiary priest comes to roughly £54,000.

Up until June 12<sup>th</sup> this year our Parish Share has been calculated on the basis of our having one Vicar (the full cost of which comes out of the Share) and one Curate (the full cost of which is born by the Diocese as a whole). However, once Chris Clayton is licensed as our Associate Vicar (on 12<sup>th</sup> June), our Share is

calculated on the basis of our having *two* full-time priests. This is why the Share has jumped £30K from £159,838 last year – and will increase by a similar amount in 2023. It is exceptionally good news that Chris is able to stay with us as Associate Vicar – but we need to recognise that, from  $12^{th}$  June, he is no longer 'free'.

A quick calculation will show you that a Parish Share of £189,858 is a good deal more than the actual costs of two full-time priests. This is because we are part of a network of Church of England churches across the Diocese of Leeds. We are relatively rich in resources compared with some of our neighbours in Bradford, Wakefield and Leeds. We pay extra to help maintain Christian worship and service in these areas. Without our support, some of these churches could not be able to operate at all.

## Staff Costs and the Cost of the Building

There can't be many churches that have such a dedicated and

stable team looking after the building, lettings and administration. Most of the costs of this team have, in the past, been covered by lettings. During the pandemic we received furlough payments but now, as lettings gradually recover, there is a shortfall to be met.

The costs of our musical worship are also remarkably low. John Longstaff, Organist and Director of Music, is an amazing gift to St Peter's as are all the talented musicians and singers, including Jude Williamson, Leader of the Music Group, who give up their time voluntarily to serve our musical worship at 9.30am, 11.00am and 6.30pm week by week.

After the Parish Share our next biggest expenses are associated with the building. As we all know energy bills are rapidly on the rise – putting nearly an extra £20,000 on our predicted outgoings for 2022. Strenuous efforts are being made to cut our energy consumption and we can be sincerely grateful for the care and expertise being applied to this by our Environment Group. Our building, in its prime location, is an invaluable asset but, as you might expect, it costs a good deal to maintain.




## Gifts, Grants and Legacies

The financial story at St Peter's during the Pandemic is opposite to what you might expect. While many other charities and churches have been struggling for funds St Peter's has benefitted from some extraordinary individual acts of generosity. Over the past two years we have received over £400,000 in one-off gifts, legacies and grants. This has meant that, despite a drastic loss of income from lettings, fundraising activities, and plate donations, we have been able to continue paying the bills. This is not, however, a sustainable model – oneoff gifts, by definition, don't happen every day. We must, therefore, broaden the base of our regular giving so that the worshipping and serving life of the church can continue to flourish.

## **The Parish Giving Scheme**

So, how can you help? Regular giving by Standing Order has been essential to the health of our finances over the past two years. We are sincerely grateful to everyone who has continued to give by this means even when they haven't been able to attend worship in person. Giving by Standing Order does, however, have its weaknesses. The problem is two-fold.

First, we tend to give the same amount from one year to the next – which means, over time, the value of our contribution gradually decreases with inflation. Second, Gift Aid applications must be made by hand. The labour involved is worth it – the total value of Gift Aid recovered is about £30,000/year – but

the process is laborious and sometimes we don't receive the recoverable funds for many months. These two problems are solved by the Parish Giving Scheme (PGS). It couldn't be simpler to use. A printed step-by-step guide is available on the Welcome Desk and on the church website – and there's a simple summary on the back of this leaflet.

Once you've set up your Direct Debit, the PGS will tell you when your first payment will be taken – so you can cancel your Standing Order, if you have one, before that date. If you're new to St Peter's, and you'd like to support us with regular giving, please do join the PGS.

## **Every contribution is precious**

Not all of us are able to contribute to the church financially. Not all of us are able to sign up for the Parish Giving Scheme or give using Gift Aid. In the current financial climate not all of us are able to increase our giving – some of us will need to reduce it. That is why it is so important that we do what we can do, not what we can't. When we offer what God calls us to offer, no matter how insignificant it may seem, he has a habit of doing amazing things with it. St Peter's, by the grace of God, has continued a remarkable ministry of worship and service every day of the pandemic. He surely has plans for us for the future also – and I am confident that those plans include a place for each of us to offer the gift that only we can give.
